Our January speaker was Andrew Friedson, the immediate past president of the Montgomery County Council. Andrew represents Council District 1, which covers part of southern and all of western portions of the county.

We invited him to speak on recent county legislative achievements with respect to matters of interest to veterans, primarily property tax credits. In his extended remarks, he showed himself to be a clear advocate of more affordable housing in the county, which he described as a critical need. He commented on the chapter's recent efforts to establish a veterans home on the site of Rockville's Redgate golf course. He acknowledged that there was little unzoned and open land in the county for such a development to be realized.

This commentary led to a discussion of the county's Agricultural Reserve, which is in his district. This open land is not available for development for any residential project and never can be.

He was asked about the situation with White's Ferry, and with that, he had much to say on the subject, as he was the Council president during the most recent efforts at finding a solution. Suffice it to say, he expressed regrets that the parties to the dispute were private entities and had proved to be rather intransigent in finding some acceptable compromise that would lead to the Ferry's reopening.

He wished us well in all our efforts to support the entire uniformed services community, saying that we should never hesitate to reach out to our elected representatives in county government.

2024 WREATHS ACROSS AMERICA

On December 11th, an amazing cold day with vivid blue skies, I was joined by CAPT(R), Dave Peterson, NOAA, Secretary of the MDMOAACoC, Past President and Secretary MDMOCOC (MD05), and Past MOAA National Board member, COL. (R) Paul Hughes, USA, a historian and Montgomery County Chapter member (MD05), CAPT (R) USPHS Frances Gipson MD05 and Crystal Holmes, Women's Marine Society, in serving as the Maryland Wreaths Across America team at the U.S. Soldiers' & Airmen's Home National Cemetery in Washington, D.C. The cemetery is the first of two National Cemeteries, preceding Arlington with Civil War burials beginning in 1861. The cemetery is the final resting place for more than 14,000 veterans, including 21 recipients of the Medal of Honor, the nation's highest military honor.

During the Civil War, churches and other public buildings around Washington were commandeered for use as military hospitals to care for wounded troops or those stricken with illness on the front lines. Just days after the Battle of Bull Run, in July 1861, the commissioners of the United States Military Asylum offered six acres of land at the north end of the home's grounds as a burial ground for soldiers and officers. The first burials were conducted later that summer.

From 1861 to 1864, the cemetery accepted thousands of soldiers' remains from across the nation, which quickly filled its six acres. By 1874, there had been more than 5,600 interments, including 278 unknown, 125 Confederate prisoners of war and 117 civilians (relatives of the deceased and employees of the home). In 1883, nine acres were added to the grounds, bringing the cemetery's size to nearly sixteen acres.

On Saturday, we joined almost 1,000 participants in laying wreaths. A somber, short program, conducted by Scouts, kicked off the event. The six military services laid wreaths, honoring specific members of their service, or in the case of the Space Service, someone who had contributed to their founding. Then, over the course of just 30 minutes, participants, some representatives of their service organization, scout troops and many families with small children, fanned out and completed the laying of the wreaths. As we did so, we stopped for a moment to recognize each service member by saying his or her name, and thanking them for their ultimate sacrifice. As we moved throughout the cemetery we listened to mothers and fathers teaching their children about the service men and women buried there. Our team was honored to represent the MOAA Uniformed Services Nurse Advocates Virtual Chapter.

Protections for Military Spouses

government provide more than just an often -untapped skill set for their agency or department – their careers make it more likely for a servicemember to remain in uniform, despite frequent moves and other potential professional derailments.

For this reason, MOAA welcomes recent guidance from the VA and other federal agencies designed to exempt military spouses on PCS orders from recent Office of Personal Management (OPM) and Office of Management and Budget (OMB) directives regarding a federal hiring freeze, a return to in-person work for federal employees, and changes to probationary periods and administrative leave policies.

But not all agencies are making such exemptions part of their policies. And while some lawmakers are weighing in with letters to OPM and OMB urging consideration of exemptions for military spouses, they need to hear from you about how important this issue is to the financial wellbeing of military families, and to the health of the allvolunteer force.

Without this protection, the new guidance could negatively impact military spouses who have been offered federal positions, are in a probationary hiring status, or are currently working for the federal government.

Recognizing the Need

Three executive orders (EOs) in the past 17 years recognized and addressed persistent un- and underemployment challenges military spouses face. The FY 2024 NDAA further clarified the importance of expanding re-

Urge Your Lawmakers to Secure Federal Job mote and telework options for federally employed military spouses.

A VA memo issued Jan. 24 notes that Military spouses working for the federal the new federal policy "allows for exceptions for military spouses with permanent change of station orders. Current arrangements to include Domestic Employee Teleworking Overseas (DETO) arrangements will not be modified unless there is a basis for revisiting or revising the arrangement." This memo should be a model for other agencies moving forward.


> The same day, the Department of Health and Human Services issued an agency exemption to military spouses with permanent changes of station, noting, "Current Workplace Flexibility Agreements will not be modified unless there is a basis for revisiting or revising the arrangements."

> However, other department-wide guidance such as that issued by DoD and the Labor Department lacked similar provisions. Additional OPM and OMB guidance on return-to-office plans issued Jan. 27 included language in a footnote exempting military spouses working remotely under language in the FY 2024 NDAA. However, without more specific direction from OPM and OMB, there are significant concerns military spouses on the move could face additional difficulties keeping, or securing, federal positions despite their qualifications. Visit MOAA's Legislative Action Center and ask your lawmakers to urge OPM and OMB to establish exemptions for military spouses to ensure they can continue to make their valuable contributions to our federal workforce while helping support their families


